Mission statement

The association advocates open access to data, information and knowledge as well as the free reusability of data ("open data"). We are committed to a society in which everyone has the same opportunities to access information and to actively shape our future.

Aims

Opendata.ch helps to shape the digital transformation of society by actively promoting a culture of openness, transparency, participation and cooperation:

- Opendata.ch supports public and private institutions and organisations in ensuring transparency and accountability through open data. By enhancing the traceability of their actions, they are expected to be better equipped to acquire and maintain the trust of citizens, customers, etc.
- Opendata.ch supports public administrations and private organisations in establishing and expanding a sustainable and open data ecosystem with crossorganisational cooperation along the entire data value chain, in securing the longterm availability of data, and in promoting their secondary use.
- Opendata.ch supports the cooperation between organisations and networking
 with citizens and customers, so that new ideas, new solutions and new services
 can be developed thanks to an ever-growing base of open datasets and constantly
 expanding technical possibilities. Those affected by policies and new technologies
 need to be able to actively shape them.
- Opendata.ch is committed to equal access to data and information for all. This
 includes promoting the ability to use data and information effectively. Everyone
 should have the chance to contribute creatively to solving societal challenges and
 to participate in politics by exchanging evidence-based arguments.

Fields and forms of action

To achieve its goals, the association Opendata.ch cooperates with partners from the private and public sectors and focuses its activities on the following areas:

- promotion of the publication, improved findability, and the use of existing datasets in accordance with open data principles¹;
- · improvement of data quality;
- interlinking of data resources by means of linked open data;
- supplementing or enrichment of open datasets using crowdsourcing approaches;
- coordination with data providers all along the data value chain (data suppliers intermediaries – data users);
- promotion of digital skills and data literacy to enable people to handle data competently;
- development of a suitable legal and political framework.

In doing so, we make use of a range of instruments and forms of action:

- public relations and awareness campaigns;
- · active involvement in the Swiss open data community;
- organization of conferences, hackathons and other community events;
- · conducting training sessions and workshops;
- providing advice and support services;
- documenting best practices and encouraging community capacity building among practitioners.
